ELIGIBILITY & ACCEPTED MEDIUM

Participation is open to all fine art and fine craft. All work represented must be of an original concept executed and designed by the artist in attendance. Each art fair reserves the right to remove any and all works deemed not suitable at the time of the festival. It also reserves the right to select or invite other applicants in order to ensure balance of medium. In addition, EM Events, LLC reserves the right to not accept an artist for jury. In the event of this happening, your jury fee shall be returned. Submitting this application implies on your part commitment to show rules.

The following mediums are to be included in each show: ceramics, drawing, fiber non-functional, fiber wearable, paper non-functional, furniture, glass, jewelry, acrylic, oil, watercolor, pastel, sculpture, wood, mixed media, collage, photography, and printmaking. Individual consideration of any media not listed will be given upon request. Please note if a show is considered a fine craft event, then minimal two dimensional work will be accepted.

No work which has been made with commercial kits, molds, patterns, plans or prefabricated pieces is allowed. Exhibitors may not sell promotional items such as t-shirts, postcards, or notecards. Reproductions are allowed in (1) one flip bin only and must be clearly labeled, "Reproduction." Reproductions are allowed in the following shows: Riverside, Art in Your Eye, Oswego, Lakeview East and West End. If hanging, reproductions must be framed and take up no more than 10% of booth.

REPRODUCTIONS ARE NOT ALLOWED IN Geneva. If reproductions are found in your booth during the Geneva Fine Arts Fair, they will be confiscated. Please refer to each show's page for additional information on their print policy.

E - JURY (THIS IS THE ONLY ACCEPTED METHOD)

- Send four (4) images of work and one (1) image of booth display.
- All images should be in JPG format of approximately 1MB in size and no larger than 2MB each.
- Images less than 200k do not provide enough resolution to be juried effectively.

- Images submitted will receive email reply notification of receipt.

It is the artist's responsibility to make sure EM Events receives images on time. EM Events **will not** follow up with a request for images if they have received your application but no images have been sent. If you have not received notification that we received your images then it is your responsibility to follow up and make sure your application is complete.

It is helpful for us if your booth image is from an actual show. Fabricated booth images are strongly discouraged. If we feel that your booth image is not a true representation of your display you will not be juried.

Only one set of images is necessary to apply to multiple shows. Artists are strongly advised to send images of professional quality. Upon acceptance, any image submitted may be used by EM Events LLC for day of show jury purposes and possible publicity opportunity.

DISPLAY SPACE

The foot print of each display space is 10' x 10'. Each show will attempt to honor specific space requests; however, final booth location will be determined by the needs of each show. Only one exhibitor per booth allowed unless work is collaborative. All areas will be patrolled both Friday and Saturday nights. **Most display spaces are free from obstruction. All spaces are easily accessible to patrons' traffic flow.** Larger display spaces are available for an additional fee.

TENTS AND WEIGHTS

All tents must be white and must be weighted properly. Please check with your tent manufacturer on proper weighting of your tent. If it is deemed by the committee that either your tent or weights are not suitable you will be first asked to correct the situation. If that is not possible then you will be asked to leave the show with no refund available. Milk jugs with sand or water, small bricks or other such items are not considered acceptable weights. We ask that you put as much thought and consideration into how your weights look and function with regards to your booth as you do with your artwork. If you have questions regarding your tent or weights please call or email prior to each show.

ACCEPTANCE/NON-ACCEPTANCE NOTIFICATION

Acceptance or non-acceptance notification letters will be sent via email one month after application deadline.

SLIDES

We are currently no longer accepting slides for jury purposes. There are many reputable commercial sites available for the processing of slides to digital images.

TAX ID NUMBER

It is **mandatory** on your application to either list an Illinois Tax ID number or social security number as most shows are required to submit this information before receiving permits for their events.

MINIMUM/MAXIMUM NUMBER OF ARTISTS

Maximum number of artists – each show will list a maximum number of artists allowed in attendance at its events.

Minimum number of artists – each show has a minimum number of artists needed in order to proceed with each event. If it is deemed the minimum number of artists has not been reached two months out from the start date of each event then the event will be cancelled and a full refund of booth fees paid to date will be issued. Start date is considered the Friday night before the weekend of each event. Once an event has been juried, even if it is cancelled no jury fees will be refunded.

PUBLICITY

Each event is promoted through featured newspaper articles, banners, print advertising and whenever possible radio and magazine promotion. Free postcards will also be made available for your mailing list.

AWARDS

Ribbons awarded where excellence is determined regardless of media. Ribbon award winners selected by professional judge(s). Judges change each year. Award money for each show varies. Call for additional details.

Geneva, a chic and charming historic town located on the Fox River, will celebrate its ninth Annual Fine Arts Fair in 2010. Its prestigious reputation of offering a superb selection of fine art by renowned artists and cutting-edge newcomers attracts beginning and avid collectors.

Presented by the Chamber of Commerce, the show is tucked along shady streets among 100+ specialty shops located in Victorian-style homes and century-old buildings. A “hands on” kids art area, awards for emerging and seasoned artists along with warm small-town hospitality, offer a picture-postcard setting for this juried art celebration.

NOTE: Prints, photography, digital art and computer generated art: *Prints must be produced by traditional printmaking techniques. The only medium where Giclee (ink jet) prints are allowed is digital photography and computer generated art work.* Photography may be either wet darkroom (chemicals) or digital darkroom with priority given to wet darkroom artists. Giclee allowed for digital darkroom work. We define computer generated art as an art form created entirely with a computer. Giclee allowed for computer generated work. All artists applying to either print, photography or computer generated art must submit a brief description of creative process from start to finish.

Emerging artists are required to fill out and abide by the same rules as professional artists. However the jury fee is waived and if accepted the emerging artists space fee is \$100. Please note: emerging artists are considered those artists who have never paid for a booth space at a fine art or craft fair. Each accepted emerging artist will receive one “wall” to display artwork on that is approximately 6 foot high by 8 foot long. 3-d artists will need to supply their own pedestals.

The Art In Your Eye Festival seeks award-winning artists for its sixth annual fine art festival at the beautiful Riverwalk on the Fox in downtown Batavia. Sponsored by the City of Batavia, the festival is a collaborative effort with other key organizations and reflects the spirit of Batavia’s artistic and art-supporting community. Art In Your Eye includes additional pre-festival activities focusing on art education, hands-on art experiences, and arts appreciation. The culminating two-day event at the Riverwalk includes the centerpiece outdoor fine art show, exceptional children’s art activities, continuous musical entertainment, an indoor exhibit featuring local artists, food, and free guarded bike parking to attract the hundreds of cyclists traveling the adjacent Fox River trails.
